OPENING REGULAR MEETING

Chairman Stan Helton called the meeting to order at 6:01 PM.

The Invocation was given by Zach Ratcliff.

The Pledge of Allegiance was led by Commissioner Earl Johnson.

Chairman Helton moved to the appointment of Larry Atkins to the Fannin County Water Authority to replace his vacant seat. Chairman Helton asked Anita Weaver to comment on Atkins. Weaver stated she felt Atkins would make a great asset to the Water Authority. Chairman Helton asked for a motion to appoint Atkins to the Fannin County Water Authority. Motion made first by Commissioner Sosebee. Second made by Commissioner Johnson; motion passed by unanimous vote

Chairman Helton discussed denying the variance as a technicality and Mathis reapplying under the Chairman Helton proceeded to a variance request from Big Creek Overlook. Chairman Helton stated the variance request had been tabled from the December 13, 2016 meeting. Commissioner Johnson stated he has spoken with Brandon Mathis and Mathis believed it would conserve time to apply for the variances together instead of individually. Commissioner Johnson stated his initial reaction was that the board could not give blanket variances. Commissioner Johnson inquired with Building Inspector Keith Nicholson regarding the Nicholson stated that Mathis had applied for several variances to save time but, if needed, would apply
