

Fannin County Board of Commissioners Regular Meeting Jury Assembly Room February 14, 2017 6:00 PM

OPENING REGULAR MEETING

Chairman Stan Helton called the meeting to order at 6:00 PM.

OLD BUSINESS

Chairman Helton called for a motion to approve the minutes of the January 24, 2017 regular meeting and the February 7, 2017 called meeting. Motion made first by Commissioner Johnson. Second made by Commissioner Larry Joe Sosebee; motion passed by unanimous vote.

PUBLIC COMMENTARY

Commissioner Sosebee's past remarks to Judge Weaver that checks from the Superior Court's operating account should be cleared by the board. Garner publically supported the comments and asked that, if there had been no compliance, the full board get behind Commissioner Sosebee's initiative. commented on Joe Webb's past remarks that all judges should report financially and

exceed two years. Webb also commented on the two signature policy and said citizens recommended two real signatures on checks over \$4,500, not electronic signatures. Webb stated that over the past year the board had passed a resolution for quarterly financial reports. Webb commented that the reports had only been exceed two years. Sam Walker commented that the new Science and Agriculture building being constructed by the Board of Education is in a flood plain. Weaver stated that Pickens and Gilmer counties provided office space for the APPP and Fannin did not which is why the budget in Fannin is larger. Commissioners Johnson stated he did not know what APPP was until the prior week or that Fannin County had a contract with APPP. Commissioner Johnson added that, in Fannin County, all board members must sign contracts. Commissioner Sosebee commented he did not know about the contract. Judge Weaver stated there is a line item in the budget for the APPP and that since 1998, there had never been a judge that had contract signing during the prior called meeting. Weaver stated the APPP had been started in 1998 when Pickens, Gilmer, and Fannin County commissioners and judges decided it would be more economical for the circuit to form the APPP rather than each county having a separate county probation department. Weaver gave a summary of the services provided by the APPP and introduced Officer Holloway, the probation Judge Brenda Weaver gave an overview of the Appalachian Pretrial and Probation Program following the contract signing during the prior called meeting. Weaver stated the APPP had been started in 1998 when received personal funds from the program.

Robert Graham discussed the Volunteer Management Plan and introduced Jerry Gordon, VOAD coordinator of Famnin County. Graham stated that with the board's approval of the plan and one other plan they will be working on during the year, Fannin County would be eligible for an extra 2% disaster match from FEMA. inquired about roads that were supposedly added in 2013. Commissioner Sosebee added the roads did not come across the board. Commissioner Johnson stated he was under the impression the county had been under a moratorium for four years and did not want any roads from 2012 forward to be included in the list. Chairman Helton commented the board had held a workshop where county roads were discussed. Chairman Helton called on Zack Ratcliff, Director of Public Works, to discuss the county road list. Ratcliff suggested revising the list to add or remove roads every six months. Chairman Helton commented that when roads are removed or added it will be a full board decision and must be noted in the minutes. Chairman Helton noted Chairman Helton made a motion to add or remove roads to the county list in July and January. Second made by Commissioner Sosebee; motion passed by unanimous decision. past confusion about county roads and recommended placing a moratorium on adding roads until July to accumulate information and do research on the roads. Commissioner Sosebee added that Kirby's husband, Sheriff Dane Kirby, made approximately \$75,000 per year bringing the total for both Rita Kirby and Dane Kirby just under \$1,000,000. Commissioner Sosebee stated he took the situation as blackmail.

Chairman Helton stated the separation agreement was for the amount of \$13,622.07 and he struggled with it as well.
