

Fannin November 14, 2017 at 5:15pm County Board of Commissioners Jury Assembly Room Regular Meeting

OPENING REGULAR MEETING
Chairman Helton called the meeting to order at 5:15pm.
The invocation was led by Robert Graham and the Pledge of Allegiance Ď, Commissioner Johnson

OLD BUSINESS Chairman Helton made a motion to approve minutes for the October 24, 2017 minutes. Second made by Commissioner Sosebee.

PUBLIC COMMENTARY
First to speak was Raiph Gamer. He expressed positives under his leaderships: overhauling the Road Department, constructing the new Fire Station, and hiring an inhouse CPA. Gamer also expressed his concerns for Chairman Helton not allowing citizens to question department heads, Animal Control's "careless" work ethic, abuse of overtime by animal control, citizens having to pay for open records requests of checks over \$4500.00.

Robert Graham of EMA presented a proposal for a new Medix Ambulance that is identical to the truck that EMS recently received. The only difference is that ambulance will be built on a 2018 chassis rather than the 2017 chassis. Dealer would charge the same amount that he charged for the 2017 chassis ambulance that was received this year. This ambulance would not be delivered until the end of January and would not be billed until delivery. Total amount of ambulance is \$124,280. Motion made by Chairman Helton to approve purchase. Second made by Commissioner Sosebee. Motion Passed unanimously.

Proclamation was presented by Pruitt Healthcare and signed to declare November as Hospice and Home Health month

Variance request made by Barry D and Ana M. Delphus to put a garage 8ft from Dial Escape Road. Commissioner Johnson stated his limit was 10ft. Stated 8 ft was too close. Commissioner Sosebee stated he thought it was too close as well. Motion made by Commissioner Johnson to reject motion until it could be moved to 10ft to be reconsidered. Second made by Commissioner Sosebee. Motion passed unanimously.

Rainbow Road right of way was next on the agenda. Residents were under the impression that road would be paved but that has not taken place. So now it is being requested that road goes back to private. Commissioner Sosebee stated that he did not blame them if the road was not going to be maintained. Commissioner Johnson said that county could get it back on the tax registry. Motion made by Chairman Helton to return the Right of Way of Rainbow Rd. Second made by Commissioner Sosebee. Motion passed unanimously.

Fire Chief Larry Thomas presented a request to purchase a firetruck (that is safety yellow in color) that would take the place of engine 13. The truck is located in Virginia and is great shape. Thomas asked for the truck to be purchased out of this year's budget. Original asking price for truck is \$49,500.00 but after speaking to seller price was reduced to \$45,000. Thomas stated that the truck brand new would run between \$260,000 and \$270,000. Commissioner Johnson stated he preferred uniformity with the color of the firetrucks. Commissioner Sosebee made a motion to approve purchase. Second made by Commissioner Johnson. Motion passed unanimously.

Next on the agenda, the Fire Fighters Cancer Insurance policy that is mandated by the state. (on the cancer policy. Second made by commissioner Sosebee. Motion passed unanimously Chairman Helton made a motion to sign the resolution

Eddie O'Neal submitted quotes to resurface the basketball court at the Rec Center. Prater quoted \$8735.00 and Stevens quoted \$10,900.00. O'Neal stated that Prater had finished job in 2015 and had done a great job. O'Neal said the court time would be shut down on a Friday the 13th of December and opened on Monday the 16th. Commissioner Johnson made a motion to approve the bid from Prater in the amount of \$8735.00. Second made by Chairman Helton. Motion passed unanimously.

Following O'Neal was the permit to approve 10 additional chimpanzees to the Project Chimp Facilities. approve. Second made by Commissioner Johnson. Motion passed unanimously. Commissioner Soce in E

Zack Ratcliff of the Public Works Department came to the front to ask for approval to purchase a Track Hoe from the Water Authority in the amount of \$42,000. Commissioner Sosebee stated that we had more equipment than men to operate equipment. Commissioner Johnson stated he did not think that the equipment was needed and that the Water Authority could sell it to someone else and didn't know why the Water Authority ... would be selling it.

Next on the agenda, was to approve a lease for the school buses to run for the Rec Department for the Thanksgiving and Christmas breal Rec. Department would pay the drivers and would pay for the fuel while it is being used for the Rec Department. Commissioner Johnson was very generous of the BOB and Requested that O'Neal Express the BOC thanks and appreciation. Chairman Helton made a motion to the lease. Second made by Sosebee. Motion passed unanimously. breaks.

Last on the agenda, Chairman spending limit. Chairman Helton stated the current spending limit was too low at \$4,500. There have been approximately 400 checks that we must have 2 signatures and noted during the audit that purchase orders were being paid over \$4500.00 without puror approval. Chairman Helton went on to say that the surrounding counties the Commissioners had much higher spending limits. The Chairman asked Commissioner Johnson his thoughts on the matter and he replied, "no absolutely not."

Commissioner Johnson went on to say that the other counties had a county attorney that worked for the entire board and that Fannin County had an Attorney that worked for the Chairman and stated any situation that would come up he could not get a straight answer from the attorney. Stated that he too did not agree with raising the spending limit. Stated that Chairman Helton knew what the limit was when he was running for

Chairman Helton stated the main issue was the audit and that things needed to change this year to comply for next year. Chairman Helton stated that he did not want this to show negative on the County or the BOC.

Commissioner Johnson asked about some of the other issues that had been sighted in the audit in the other departments. Robin Gazaway spoke up and mentioned several corrections that had been made. Commissioner Johnson added he was beginning to see a pattern going the wrong way and there were too many tweaks happening. Commissioner Johnson said he would like to change things and have the County Attorney, Lynn Doss work for the BOC and not just Chairman Helton. Commissioner Johnson said it had nothing to do with Doss it had all to do with structure of the

Commissioner Johnson made the motion to move the County Attorney, Lynn Doss to be under the discretion of the full Board. Chairman Helton denied the request. Commissioner made the motion again under Home Rule. Chairman Helton stated that Home Rule had a different process. Commissioner Johnson made the request again. Chairman Helton stated the only motion he would make would be that the meeting be adjourned. A second was not made. Chairman Helton asked Commissioner Sosebee if he would like to second the motion and Commissioner Sosebee did not reply. At that time, Chairman Helton said a 5-minute break was in order. Meeting broke for 5 minutes at that time.

Meeting went back in session after breaking. Commissioner Johnson stated that the County Clerk only recorded Chairman Helton's comments in the minutes and that Lynn Doss only answered to Chairman and that the county was in a pickle with the "system" that the county is under.
