PUBLIC HEARING ON LOCAL LEGISLATION CHANGES

OLD BUSINESS

Commissioner Sosebee made a motion to approve minutes for the September Johnson. Motion passed unanimously. 26, 2017 minutes. Second made by Commissioner

PUBLIC COMMENTARY

Joe Webb approached the podium again and had three concerns. First, the crosswalk at Shallowford Bridge and Aska Rd needed to have crosswalk repainted. Second, Said Commission had not written a Chairman Narrative. Third, changes in budget not sent Commentary was then closed.

First, to the podium in new business was Nicole Potzauf, director of Blue Ridge Mountain Arts Association. Potzauf reported that the Art Center had 2000 visitors for the month of September and presently has 149 art students and approximately 238 art classes have been held this year. The Art Center is presently showcasing Southern Appalachian Artist Guild Show. Potzauf thanked the Commission for closing early on Friday, 13th of October to allow artists to set up for the big Arts in the Park Fall Event. Stated in previous years the event has drawn in over 8000 in attendance.

North Georgia Mountain Crisis Center Network presented the Commission with a proclamation to declare October as Domestic Violence Awareness Month. This was signed and pictures were made my madia This was signed and pictures were made my media.

The Development Authority reappointments were next on the agenda. Commissioner Sosebee made a motion to reappoint Mrs. Billie Queen for another 3-year term. Second made by Commissioner Johnson. Motion passed unanimously. Commissioner Johnson made a motion to reappoint Mrs. Marilyn MacNeil for another 3-year term. Second made by Commissioner Sosebee. Motion passed unanimously.

Variance request made by Angela L. Smith, that was previously tabled in prior meeting, due to some further planning that was needed. Smith is proposing a garage be built 17.3 feet from the existing edge of Campbell Camp Circle. Improvements also include a permanent berm and retaining walls. Motion made by Chairman Helton to approve variance request. Commissioner Sosebee

Variance request made by Toccoa River Dreams LLC to build new home with porch 35 feet from the edge of Toccoa River. On the contingency that the property owner build rock retaining wall on river bank. Chairman Helton stated that the county requires a 50-foot buffer from the river and he did not approve variance. Chairman Helton made a motion to reject variance. Second made by Commissioner Sosebee. Motion passed unanimously. Variance denied.

Variance request made by Paul and Ruth Roth to place a garage, 25 feet from the edge of Rocky Point Drive. Rocky Point Drive is a private road. Motion made by Commissioner Sosebee to approve variance. Second made by Commissioner Johnson. Motion passed unanimously.

Last on the agenda was a resolution to apply for a walking path grant for Horseshoe Bend Park. If the grant is obtained, it would help make improvements such as restrooms and the walking path. Commissioner Johnson stated that he believed Horseshoe Bend Park was the "Jewel" of Fannin County. Chairman Helton made a motion to pass resolution to apply for grant. Second made by Commissioner Sosebee. Motion passed unanimously.
