## **OPENING REGULAR MEETING**

Chairman Helton called the meeting to order at 5:15pm.

The invocation was led by Lane Bishop and the Pledge of Allegiance was led by Commissioner Johnson.

### OLD BUSINESS

## **NEW BUSINESS**

Nicole Potzauf address the Board concerning the Blue Ridge Mountain Art Association. Stated approx. 41,000 guests had visited the Association in 2017 and 580 had visited in the month of January. Also, mentioned was that the facility was opened 52 hours a week and had night hours to accommodate community groups, yoga, art classes and dance classes.

The Art Association will be hosting the young artists of the community and will include Copper Basin in the month of March. Other Upcoming events are May 26-27 Arts in the Park, April 18 UNG Lunch and Learn.

Variance request made by Watkins Home Builders to build home 27 feet away from Bill Claypool Dr. Motion made by Chairman Helton to approve variance. Second made by Commissioner Sosebee. Motion passed unanimously.




Graham also stated, that a Trauma Grant was received and new laptop computers were able to be purchased for the ambulances.


Next on the agenda, Chairman Helton thanked Lane Bishop for his work with the Tax Assessors Board and stated that his appointment was ending on 2/28/2018.

O'Neal asked for approval to apply for an ARC grant. This grant is a federal grant and the county could possibly obtain it quicker than the state grant. This grant is a 70% grant and 30% of county funds. Motion made by Chairman Helton to apply for grant. Second made by Commissioner Sosebee. Motion passed unanimously.
