

# Fannin County Board of Commissioners Regular Meeting Jury Assembly Room January 8, 2019 5:15 PM

## OPENING REGULAR MEETING

Chairman Helton called the meeting to order at 5:15 PM.
The Invocation was led by Zach Ratcliff and the Pledge of Allegiance was led by Commissioner Johnson.

Webb offered recommendations to the Post Two Commissioner.

agenda and would take the vacant slot Chairman Helton stated there was a change to the agenda. Chairman Helton commented that the Chamber of Commerce was not able to attend the meeting, but that Fire Chief Larry Thomas needed to be on the

more this year. Thomas stated the volunteers needed the Board of Commissioners' approval to borrow the additional funds. A board discussion followed, and Commissioner Johnson inquired about the note. Thomas stated it would be a three year note and they were looking to pay it off the next year. Executive Director of Fannin County Development Authority Christie Gribble presented a new youth program through the Development Authority, Fannin Youth Initiative. Gribble explained that the program would be a youth version of Leadership Fannin. Gribble stated that the goal is to have 12 students complete the program the first year. Gribble explained aspects of the program including mentorship, economic development, and more.

The next item on the agenda was a resolution to change the signature cards on all bank accounts. Finance Director Robin Gazaway explained the change would be removing prior Post 2 Commissioner Sosebee and adding current Post 2 Commissioner Patterson. Motion made first by Chairman Helton. Motion made second by Commissioner Johnson; motion passed unanimously.

Sherry Morris of Fannin County Family Connections gave an overview of the services provided by Family Connections. Morris stated that the Board of Commissioners has acted as the fiscal agent for Family Connections for many years and asked the board to serve as the fiscal agent for the 2019 year. Chairman Helton made a motion to continue as the fiscal agent for Family Connections, starting July 1, 2019 through the end of June 2020. Second made by Commissioner Patterson; motion passed unanimously.

Chairman Helton stated that the wireless phone bill for Fannin County runs approximately \$150,000 per year. Chairman Helton stated he had invited Steven Small to present opportunities to save money. Small, from SDS Wireless Consulting, gave an overview of Fannin County's Verizon bill and potential savings. Motion to enter into a three-year contract with SDS Wireless Consulting, LLC made first by Commissioner Johnson. Motion made second by Commissioner Patterson; motion passed unanimously.

commented that if there are any changes or a cancellation to the contract, it must be done 180 days prior to the contract ending. Commissioner Johnson commented on looking into the tonnage that the county is producing and to see if the transfer stations could reduce the price per tonnage. Chairman Helton addressed the board concerning the Advanced Disposal contract. Chairman Helton

Board of Assessors Chairman Troy Junnier inquired about the budget being reevaluated in six months. Commissioner Johnson stated the best idea would be to have more dialogue and did not believe the assessors would need the additional funds. Commissioner Johnson stated were meeting half way. Commissioner Johnson made a motion to approve an increase to \$658,493. made second by Commissioner Patterson. Motion opposed by Chairman Helton. Motion carried 2-1 he was not getting exactly what he wanted and Junnier was not getting exactly what he wanted but they

Chairman Helton stated the board needed Executive Session for personnel and potential litigation. Motion to enter Executive Session made first by Chairman Helton. Motion made second by Commissioner Johnson; motion passed by unanimous decision.

Motion to come out of Executive Session made first by Chairman Helton. Motion made second by Commissioner Patterson; motion passed unanimously.

Chairman Helton stated that no decision was made during Executive Session.
