OPENING REGULAR MEETING

Chairman Helton called the meeting to order at 5:15 p.m.

NEW BUSINESS

First on the agenda was Item #3, variance request from Stephen F. Boller & Catherine M. Ramsdell to build a garage on Old Toccoa Loop. The Northeast corner of garage will be 21 feet from the edge and 34 feet from the centerline and the Southeast corner of garage will be 25 feet from the edge and 40 feet from the centerline of Old Toccoa Loop. Next on the agenda was Item #5, an Alcoholic Beverage License application from Stephanie Nicole Cots. Chairman Helton stated publication had been advertised in the legal organ prior to the meeting and this was just to place the public on notice of the request. Chairman Helton stated no action was necessary at this time. Item will be placed back on the agenda for October 22, 2019.

Next on the agenda was Item #6, Director Kim Pirkle with the North Georgia Mountain Crisis Network came forth to speak regarding the Crisis Network serving the areas of Fannin, Gilmer & Pickens Counties and the benefits in which they provide for our communities. Chairman Helton declared the month of October to be Domestic Violence Awareness Month and proceeded with signing the Proclamation

Next on the agenda was Item #7, Director of Public Works Zack Ratcliff came forth with a request to purchase a 2019 Leeboy Tack Distributor from Reynolds-Warren Equipment for a total of \$13,600.00. Mr. Ratcliff stated this would be paid out of SPLOST. Chairman Helton made motion first to approve purchase. Commissioner Patterson made motion second. Motion passed unanimously

Mr. Ratcliff also requested the approval for engine repairs to a 2002 dump truck. He stated the cost to rebuild the engine would be in the amount of \$9,615.30 which included labor and parts with a thirty or sixty

day warranty. Mr. Ratcliff stated the dump truck has 500,000 miles on it presently. Chairman Helton made motion first to approve repairs for the dump truck. Commissioner Patterson made motion second. Motion passed unanimously.

Next on the agenda was Item #8, Land Development Officer Marie Woody gave an update on the Condemnation List for 2019. Ms. Woody also presented to the Board a list of Fannin County Residential Building Permits issued to date showing a total of 218.
