OPENING OF REGULAR SCHEDULED MEETING:

Present in meeting were Chairman Jamie Hensley, Post Two Commissioner Glenn Patterson, Post One Commissioner Johnny Seearce via zoom, County Attorney Lynn D. Doss, & County Clerk Sherri L. Walker.

Item #1: Invocation was led by Post Two Commissioner Glenn Patterson. Pledge was led by Chairman Hensley.

UNFINISHED BUSINESS:

Item #2: Approve minutes of the June 14th, 2022 Regular Scheduled Meeting. Chairman Hensley made a motion first to approve the minutes. Motion made second by Commissioner Patterson. Motion passed unanimously.

NEW BUSINESS:

Item #3: Variance Request from Fred Glennon & Helen Johnstone to place a garage 20 feet from Highland Gap Road and 27 feet from the centerline of Highland Gap Road. No party was present to oppose variance. Mr. Glennon was present for variance request. Chairman Hensley asked for a motion to approve the variance. Motion made first by Commissioner Patterson. Motion made second by Chairman Hensley. Motion passed unanimously.

Item #4: Board Action on FY2021 Audit & Budget Adjustments. Chairman Hensley stated "Based upon having a flat budget for 2021, the adjustments for the Budget Amendments are based upon the 3% salary increases and ARPA compensation given to employees along with some other expenditures in the departments. Overall, these are mostly made up of salaries. The original budget for the General Fund only accounted for revenues from the property tax. The county did conservatively estimate revenues while receiving more than anticipated. The General Fund increased in Fund Balance by \$6,161,571 due to receiving more revenue than incurred expenditures." Chairman Hensley made a motion first to approve the FY2021 Audit & Budget adjustments and approve the final draft of the Fannin County Annual Financial Report for Fiscal Year Ending December 31st, 2021. Motion made second by Commissioner Patterson. Motion passed unanimously.

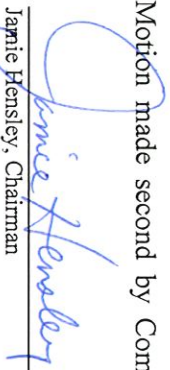
