OPENING OF REGULAR SCHEDULED MEETING:

Present in meeting were Chairman Jamie Hensley, Post One Commissioner Johnny Scearce, Post Two Commissioner Glenn Patterson, County Clerk Sherri L. Walker & County Attorney Lynn D. Doss was not present.

Item #1: Invocation was led by Pastor Chris Clark. Pledge was led by Commissioner Scearce.

Mr. John Joanides came forward to express concerns regarding the site where numerous trees were removed and the existing real estate sign being too close to the roadway. After discussions between parties, Chairman Hensley made a motion first to approve the variance request with the stipulations of Mr. Norton replanting some trees to replace the ones that were removed and to have the real estate sign set back from the roadway based on the sign ordinance regulations. Motion made second by Commissioner Scearce. Motion passed unanimously.
